## Notice of SEPA Action <u>2<sup>nd</sup> Revision</u> Washington Department of Natural Resources Bridge Replacement

Pursuant to WAC 197-11-340, Kittitas County Community Development Services did on January 31, 2019 issue a Revised Mitigated Determination of Non-Significance (MDNS) on the proposed replacement of a bridge by the Washington Department of Natural Resources on parcel # 129234, zoned Commercial Forest, approximately 3 miles north of Cle Elum. This Notice is issued to correctly identify the issuing agency on the associated Forest Practices Hydraulic Project approval as the Washington Department of Natural Resources in condition 3 under the Water heading.

The lead agency for this <u>originally</u> revised its SEPA threshold determination of Non-significance issued on December 31, 2018 after comment from the Washington Department of Fish and Wildlife and the Washington Department of Ecology. An Environmental Impact Statement (EIS) is not required under RCW 43.21C.037(1) and WAC 197-11. This 2<sup>nd</sup> revision is to correct a scrivener error as listed above and does not change the intent of the revised MDNS. This decision is made after review of a completed environmental checklist and other information on file. This decision was made after review of a completed environmental checklist and other information on file with the lead agency, after considering voluntary mitigation measures which the lead agency or the applicant will implement as part of the proposal, and after considering mitigation measures required by existing laws and regulations that will be implemented by the applicant as part of the Kittitas County process.

This 2<sup>nd</sup> Revised MDNS is issued under WAC 197-11-340(2); the lead agency will not act on this proposal for 15 days.
