KCPW Fairview Road Culvert Replacement Project

NOTICE IS HEREBY given that pursuant to WAC 197-11-340, Kittitas County Community Development Services did on March 25, 2019 issue a Determination of Non-Significance (DNS) on the proposed Fairview RD culvert replacement. The project will create a new channel alignment, through use of one larger culvert to replace the 3 existing culverts.

The lead agency for this proposal has determined that the proposal will not have a probable significant adverse impact on the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C.037(1) and WAC 197-11. This decision was made after review of a completed environmental checklist and other information on file with the lead agency.

This DNS is issued under WAC 197-11-340(2); the lead agency will not act on this proposal for 15 days. Any person, affected tribe, or agency may submit comments to the lead agency within 15 days of the date of issuance of the DNS.
