Description: The proposed project will add a mobile office, truck scale, and rebuild a barn at the

Hajny Trading Facility adding approximately 21,940 sq. ft. to the existing 20,000 sq. ft. for a proposed total of 41,940 sq. ft. The proposed structures are a permitted use under KCC 17.15.060.1. A SEPA review is required due to the use exceeding the minimum 30,000 agriculture structure square footage threshold pursuant to

KCC 15.04.090(b)(ii).

Location: The project site is located approximately 1.5 miles east of the City of Kittitas. The project site is

in Section 8, T17N, R20E, at 51 Prater Rd, Parcel #450633.
