DNR Southeast Region appreciates the opportunity to provide input on the "Malsam SEPA SE-21-00025" relating to the proposed clearing and grading and subsequent building of a residence on the three (3) acre parcel in Kittitas County. Based on information provided in the SEPA checklist and a cursory review of the area, please accept the following comments:

- An approved Class IV-General Forest Practices Application (FPA) is required prior to any conversion activities, including timber harvest, stump removal, clearing and grading, road/driveway construction, etc.
- The project area falls within the WDFW "Bull Trout Overlay" area (See full definition in Forest Practices Rules, WAC 222-16-010 *General definitions.)
- The project area also falls within the USF&WS "Bull Trout Populations of Concern". This data layer of bull trout local populations is a subset of all the bull trout local populations in Washington State as identified by the U.S. Fish and Wildlife Service. This subset of local populations was created specifically for the Washington Department of Natural Resources and in regard to the Washington Forest Practices Habitat Conservation Plan (FPHCP).
- The project area is located within the "I-90 Spotted Owl Special Emphasis Area", however the parcel is mapped as "Non-Habitat, no potential for future habitat" regarding Northern Spotted Owls (i.e. noted, but no conflict)
- The project area is noted by WDFW spatial information as Priority Habitat for "Domerie Elk Winter Concentration Area"

Thank you for the opportunity to comment on this project.

With the proposed house/garage and shop complex being moved 120 feet closer to the north property line, this leaves less room for the installation of the primary and reserve drain fields. The concern becomes if there will be adequate square footage for the drain fields. An additional concern is if the drain fields will be placed in the native soil with the grading and leveling taking place in the proposed building site. The existing design with our office has expired and with the proposed changes in this application and the locations of the structures, our office will be requiring another site evaluation and a re-design will be required as well.
