

The proposed project includes improving an existing driveway to County standards and obtain approval from Public Works as part of a single family residential building permit for Parcel #19162. The existing driveway starts at Alice Rd between parcels 425834 and 133236, and extends through Parcel #19162. Proposed improvements include surfacing, widening as needed to meet County standards, and re-estbalichsing and installing new drainage swales as needed.

Erosion is not anticipated due to the controls that will be in place during the work including a stabilized construction entrance, covering of stockpiles, and silt fence as needed.


