The Owens mitigation plan will consist of the exact recommendations that Jen Nelson from the WDFW felt necessary to maintain the best wildlife habitat. I will attach a copy of her statement.

- 1. When building the road we will do our best to avoid damaging any woody vegetation while also complying with the county regulations of road grade.
- 2, After the road is complete we will seed all road shoulders and all areas where the natural ground surfaces were disturbed with native bunch grasses and forbs.
- 3. Although not a requirement, we will do our best to locate and plant some bitter brush, mock orange and choke cherry on some of the sides of the driveway.

  4. We will do all of this after the driveway is complete. Depending on when this project gets done, we will seed before winter or early in the spring so the grasses will have the best chance to germinate and ensure good growth.

Hi Rachael,

I was able to meet with Mr. Owens onsite today to see the project area. As I understand it, he appears to be minimizing disturbance as much as possible while meeting everyone's regulations. Given the steep slopes onsite, we anticipate the future building locations to be toward the top of the hill (eastern portions of the parcels) such that the existing diverse vegetation on the steeper slope will largely be undisturbed and remain good wildlife habitat.

We do recommend avoiding existing woody vegetation as much as possible during road construction and that all disturbed areas be seeded with native bunch grasses and forbs. Additional native plantings of bitter brush, choke cherry, mock orange and ponderosa pine would be beneficial as well, but the grass seeding will be the most critical mitigation component moving forward.
