

The project is located at the Kittitas County Airport (Bowers Field), approximately 0.44 miles east of the intersection of Airport Road and West Bowers Road, in Section 24, Township 18, Range 18 in Kittitas County.

Proposal: The applicant, Airport Holdings, LLC, is proposing to construct aircraft hangar facilities to house an FBO, aircraft repair shop, county airport maintenance facility, and other commercial aircraft storage and business needs.
