NOTICE IS HEREBY given that pursuant to WAC 197-11-355 and RCW 43.21C.030(2)(c), Kittitas County Community Development Services did, on December 21, 2022, issue a Mitigated Determination of Non-Significance (MDNS) on the proposed SEPA application submitted by Airport Holdings LLC. The applicant is proposing to construct aircraft hangar facilities to house a fixed-base operator (FBO), aircraft repair shop, county airport maintenance facility, and other commercial aircraft storage and business needs. The project is to consist of two phases with two buildings in each phase. The subject project location is in Light Industrial zoning in the Airport Overlay Zone. The project is located at tax parcels 955321, 955322, 955323, 955324, 955325, 955326, 955327, and a portion of 961148, at the Kittitas County Airport (Bowers Field), approximately 0.44 miles east of the intersection of Airport Road and West Bowers Road, in Section 24, Township 18, Range 18 in Kittitas County.

The lead agency for this proposal has determined that the proposal will not have a probable significant adverse impact on the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C and WAC 197-11-355. This decision was made after review of a SEPA environmental checklist, and other information on file with the lead agency.
