Mr. Storch asked me who would respond in the event of a fire at this location, and I confirmed that

SPFR and Eastside Fire & Rescue would respond. ESFR is our primary backup agency for major incidents and depending on how significant the incident is we could have more units that or dispatched by NORCOM (City of Snoqualmie, Fall City, Bellevue Fire etc). These agencies use the 800 mhz system that is in the process of being upgraded by PSERN. I was not aware, nor did I indicate that this area has 800 mhz radio issues. The structure fire at 181 east hyak drive last fall the 800 mhz system worked so it seemed. Understanding how the system works is a little outside my scope however I would generally support having systems in place that do support emergency radio ops as a safety measure for my responders and responder from other agencies. I think we need to get George Long the director of KITTCOM involved in this conversation.

I guess we will have to find out how to do a study and if the signal is low what do we do? Kind of odd as we have been here for decades and it has not been brought up.

Good Morning Jeremiah,

In regards to this project. KITTCOM recommends project have an assessment performed (and mitigation if needed implemented) for Emergency Responder Radio coverage as per Washington Administrative Code (WAC) 51-54A-0510.

KITTCOM's radio signal modeling indicates the location does not have sufficient signal to support WAC requirements for Emergency Responder Radio Communications in the proposed project. Furthermore, due to facilities location, Chief Wiseman, Snoqualmie Pass Fire and Rescue (SPFR) confirmed significant event responses will require radio communications on SPFR primary, KITTCOM, and Puget Sound Emergency Radio Network (PSERN) two-way radio communication channels.
