NOTICE IS HEREBY given that pursuant to WAC 197-11-355 and RCW 43.21C.030(2)(c), Kittitas County Community Development Services did, on June 6, 2023, issue a Mitigated Determination of Non-Significance (MDNS) on the proposed SEPA application submitted by the Kittitas County Airport. The applicants are proposing a wetland and stream mitigation project west of Runway 11-29 of the Kittitas County Airport. The project is proposed on a site that is zoned Light Industrial in the Airport Overlay Zone.
