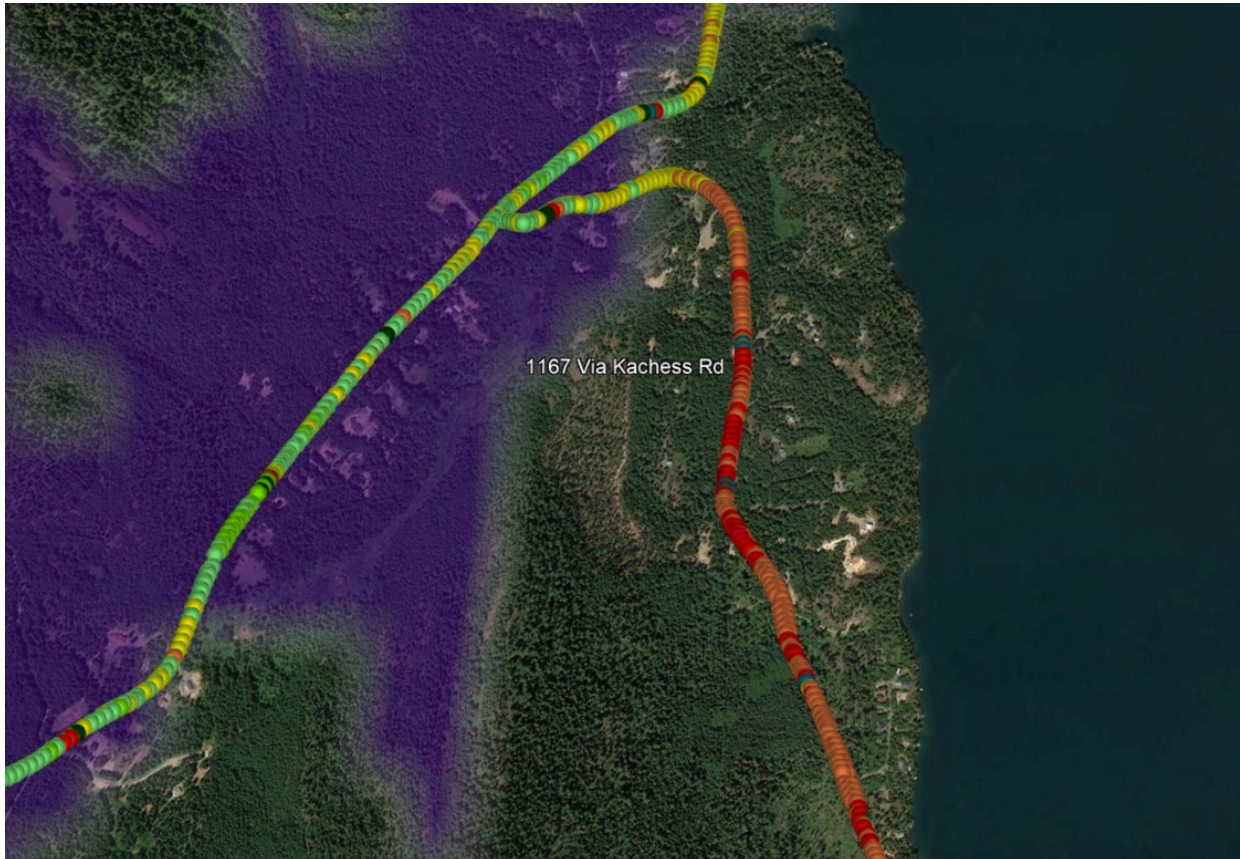
In reviewing Application SE-23-00015 Hallisey, KITTCOM recommends any occupiable building development project(s) at this location have an assessment performed to determine if mitigation is needed for Emergency Responder Radio coverage as per Washington Administrative Code (WAC) 51-54A-0510. KITTCOM notes the specific application is for road work, however Applicant mentions future structure(s) which may be under a process outside KITTCOM's view. Therefore, we are commenting on this application.

KITTCOM's radio signal modeling and drive test information indicates the location does not have sufficient signal per WAC for Emergency Responder Radio Communications at the proposed project. Specifically radio communications for Kittitas County Sheriffs Office, Snoqualmie Pass Fire and Rescue (KCFD #51), and Upper Kittitas County Medic One (KCHD #2) emergency responders.

Attached is screenshot of signal modeling and drive testing. Signals and measurements are on-street and do not take into account building materials which may attenuate (reduce) radio signals in / out of the building. Therefore, survey testing per WAC is recommended and if needed, prescribed mitigation.
