

**NOTICE OF DECISION**  
**Mid Valley Investment**  
**Setback Variance**  
**(VA-13-00001)**

Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that Kittitas County Community Development Services approved the Mid Valley Investment zoning setback variance (VA-13-0001) on March 25, 2013. Mid Valley Investment, landowner applied for a setback variance to encroach 10 feet into the rear setback for the construction of a 56 x 160 foot hay barn. The subject property is zoned Commercial Agriculture and is located approximately 1.5 miles southeast of Ellensburg at 541 Tjossem Road, in a portion of Section 13, T17N, R18E, WM in Kittitas County, bearing Assessor's map number 17-18-13040-0005.

An appeal of this land use decision may be filed by submitting specific factual objections and a fee of \$500 to the Kittitas County Board of County Commissioners, together with the applicable fee, on or before **April 5, 2013 at 5:00 p.m.** The request shall conform to the requirements of KCC Title 15A.07, Project Permit Application Process of the Kittitas County Code.
