Pursuant to RCW 36.70B.130 and KCC 15A.06, notice is hereby given that Kittitas County did on May 29th, 2018 approve a Setback Variance application on April 16th, 2018, pursuant to Kittitas County Code 17.84 on approximately 1 acre of land that is zoned Agriculture 20. The request is stated as necessary to accommodate a pole building in place of the existing carport and to avoid disturbing the existing orchard, well, septic system, and drain field. The subject property is parcel # 194334 located off of Naneum Road, Ellensburg, in section 16, Township 18 N Range 19 E, WM. Map number 18-19-16000-0009.
