Project Name (VA-23-00007): Chappelle Setback Variance

Applicant: Dan Chappelle (Landowner), Frank H. & Lissy Hamm (Authorized Agents)

Location: The subject property is parcel # 620534 (Lot 5 of Elk Meadows Park #2) located on Wapiti Drive, approximately 1,600 feet off Interstate 90. The property is in Section 22, Township 20, Range 14 in Kittitas County. Map number 20-14-22051-0005. The property is 0.48 acres and is zoned Rural-5 with a Rural Residential land use.

Proposal: The proposal requests a 10-foot reduction from the 25-foot front lot line required setback for the construction of a 1274 SF single-family residential structure. The 25-foot front lot line setback requirements come from KCC 17.30.A.050. If the variance is approved, it would result in a 15-foot front lot line structural setback for the residence, respectively.

Written Comments on this proposal can be submitted to CDS any time prior to <u>5:00 p.m. on October 9, 2023</u>. Any person has the right to comment on the application and request a copy of the decision once made.

Under Title 15A.03.080 and **17.84.010**, Zoning Variances are processed in an abbreviated administrative format, which does not involve a public hearing. All comments will be considered in the decision-making process, and any person has the right to comment on this application and receive notification of the Community Development Services administrative decision, once made. A Notice of Decision will be published once a decision is made. Appeals to an administrative land use decision may be filed within 10 working days with Community Development Services as outlined in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$1550.
