Chappelle Setback Variance  
VA-23-00007**

NOTICE IS HEREBY given that Dan Chappelle, landowner, submitted a Setback Variance application on August 28, 2023 pursuant to Kittitas County Code 17.84 on .48 acres of land zoned Rural-5 within a Rural Residential land use designation. The proposal requests a 10-foot reduction on the front (South) property line from the 25-foot front lot line setback requirement in KCC 17.30.050 for a single-family residence. This would result in a 15-foot front structural setback from the front (South) property line if the variance is approved. The subject property is parcel # 620534 located on Wapiti Drive in Cle Elum, WA bearing Assessor's Map number 20-14-22051-0005.

Under Title 15A.03.080 and 17.84.010, Zoning Variances are processed in an abbreviated administrative format, which does not involve a public hearing. All comments will be considered in the decision-making process, and any person has the right to comment on this application and receive notification of the Community Development Services administrative decision, once made. A Notice of Decision will be published once a decision is made. Appeals to an administrative land use decision must be filed within 10 working days with Community Development Services as outlined in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$1670.
