
Summary:

Agenda Item 2. Role of Technical Advisory Committee & Agenda Item 3. Introduction to RCW, WACs, County Plan/Regs.

Anna N. updated the TAC Members on Kittitas County's CAO, Voluntary Stewardship Program, CAO Public Participation Program, and Best Available Science (BAS). Anna N. also gave the TAC Members an overview of the upcoming meetings and timeline of adoption.

Agenda Item 4. Literature Sources

Margaret C. provided an overview of the literature sources and noted that applicable resources will be included as references in the individual BAS review documents, with some resources listed in an additional resources list. ESA is reviewing the City of Ellensburg BAS for relevant resources. Margaret C. also stated that the BAS memos are not site specific.





John M. noted some the Yakima County BAS was included in the list.

Sean G. asked if the King County BAS was included in the study.

Liz R. stated yes, some names on the data sheet are from King County.

Anna N. stated that the group will not be using data that is specific to only Western Washington.

Sean G. asked if more sources would be included.

Anna N. stated yes, that the current list is a starting point and that the TAC should review and submit comments on the preliminary draft list.

Agenda Item 5. CAO Mapping

Anna N. and Margaret C. presented the group with an overview of the preliminary maps. Margaret C. explained where different features are located on the map.

Sean G. asked how to submit comments on the map.

Margaret C. stated circling an area on the map, creating a PDF version of the map, and emailing the PDF with the comments would be best. Margaret C. showed the TAC Members how to get to, and use the mapping tool.

There was general discussion of fish data on the map and how it is presented to the public.

Anna N. stated that in regard to E2SSB 5292, that the County is currently discussing sending a letter to each Irrigation District and asking them to provide information regarding whether their facilities met the definition of fish and wildlife habitat conservation areas. Anna N. stated she would send a draft letter to Cathy R. for review and comment first, if the County decides to send letters.

Anna N. stated the TAC comments on the Literature Sources list need to be submitted by May 24th. The draft Wetland BAS memo will be distributed to the TAC early next week for review and comment at the June 8 TAC meeting. Anna N. stated that TAC comments on the May 18 draft meeting summary need to be submitted by May 30th.
