## IMPORTANCE OF HUMAN MILK



Breastfeeding is important for the parent and baby as well. A few of the benefits are:

- Increased bonding
- Reduced risk of ovarian and breast cancers
- Financial benefits
- Reduced bleeding after birth
- Protects baby from illness and infection
- Provides complete nutrition for baby for first 6 months

Supporting nursing moms at work can help the organization.


Some benefits to employers include:

## THE PUMP ACT (FEDERAL)



#### The 2022 PUMP Act:

- Workplace protections for nursing mothers.
- Reasonable break time.
- A private place to pump.
- Employee right to file a lawsuit.
- Pumping time may count as worktime.

## WORKPLACE PREGNANCY ACCOMMODATIONS

RCW 43.10.005 requires employers with 15 or more employees to provide:

- A flexible schedule to pump and attend medical appointments.
- Reasonable accommodations.
- A convenient, private location to express milk (not a bathroom).

## KVH: ACCOMMODATION FOR BREASTFEEDING EMPLOYEES




- KVH is one of the top three largest employers in Kittitas County.


## KITTITAS COUNTY BREASTFEEDING COALITION
