## **Business**

Dr. Merill-Steskal gave a presentation to the board about the COVID-19 vaccine. The presentation included information about how the vaccines work, how well the vaccines work ("vaccine efficacy"), and how safe the vaccines are.

There were questions from the board about the source of the mRNA and possible ethical issues. There were also questions about the 95% effectiveness being clinical or transmission, as well as if adjustments are needed for other strains.

#### **Retail Food Code Revisions**

Jesse Cox gave an update to the board regarding recent Washington State Code updates, with various changes taking effect January 15, 2021, and March 1, 2022.

### **BOH Annual Orientation**

Chelsey Loeffers gave the current Board of Health (BOH) members their annual orientation for public health. The BOH orientation included information about what public health is, what the core functions are, the impacts of public health, review of the local public health system, board responsibilities, statutes that govern public health, and a review of the public health department programs. There were questions from the board to inquire if any other states use a regional Public Health model.
