More Children Vaccinated at Annual Drive Through Flu Vaccination Clinic

The Kittitas County Public Health Department (KCPHD) held the fifth annual drive through flu vaccination clinic on October 1, 2011 in the parking lot of the Grand Meridian Theater in Ellensburg

Thirteen staff from KCPHD and 38 volunteers from Kittitas County Search and Rescue, Central Washington University Paramedic Program, and nurses from local clinics participated in the vaccination clinic.

Flu vaccinations were administered to 156 children and 159 adults (total 315) in four hours.

This year, the clinic was held on a Saturday instead of during the week as in prior years. Although there were less adults than last year, there were over three times as many children compared to the 2010 clinic.

"We were really pleased that there were so many parents bringing their children to get the flu vaccination," said Linda Navarre, Community Health Services Supervisor.

In addition to providing flu vaccinations for the community, the event also serves as an emergency preparedness exercise for KCPHD staff. The event is a scenario for staff in setting up a mass vaccination site, coordinating volunteers, communicating with the media, and managing logistics.

A Note From the Administrator: Comparing 2011 to 2010

Not pictured: Melissa Schumaier, Maria Canfield, Mark Larson, Erin Moore, Jackie Dawson In reviewing our 2011 activities compared to 2010, you will notice some differences in several areas.

Significantly fewer vaccinations were administered in 2011 compared to 2010. For adult vaccinations, there was a 47% decline. For children, there was a 38.5% decline. In looking at specific vaccinations, the biggest declines are in influenza for adults and children, Tdap (tetanus, diphtheria, pertussis) for adults and adolescents, and TwinRix (hepatitis A and B) for adults.

However, this is not necessarily bad news. For adults, the last year has seen improvements in vaccine availability through alternate sources, such as pharmacies. For children, not only have there been improvements in access, new providers and more services, but also a push to link them to a medical home.

Other declines in 2011 activities are related to lack of funding and changing program priorities. These include a shift in oral health activities from dental clinics and fluoride varnish activities to the Access to Baby and

New Partnership Results in Free Flu Vaccine Clinics

In December, KCPHD partnered with Walgreens Pharmacy and the Ellensburg and Cle staff also gave flu Elum free clinics to vaccinations at the provide free flu vaccinations to adults and children over age seven.

Two clinics were held at the Ellensburg Free Clinic on a Thursday evening and a Saturday morning, one was held on a Sunday after the Spanish mass at St. Andrew's Catholic Church, and another was held

on a Saturday afternoon at the Cle Elum Medical Center. Walgreens FISH Food Bank and to Kittitas County Jail inmates.

Walgreens provided and administered the vaccine, free clinic volunteers assisted, and KCPHD helped to promote the events.

In total, about 200 people received free flu shots in Kittitas County.

Sarah Bedsaul Earns Master Trainer Certificate

In October, lead health educator Sarah Bedsaul earned her Master Trainer Certification for Stanford University's Chronic Disease Self Management (CDSM) Program. She became a program facilitator in February after partnering with Kittitas Valley Community Hospital and Aging and Long Term

Care to offer CDSM classes in Kittitas County.

In order to become a Master Trainer, she worked with another facilitator to train a group of 15 lay leaders from Yakima and Kittitas Counties.

Ms. Bedsaul cofacilitated three six -week CDSM sessions during 2011 with 41 participants.



Food Safety Code Updates Coming in 2012

The State Board of Health (SBOH) is considering updating the state food code to include cut tomatoes and leafy greens on the list of potentially hazardous foods. In addition, date marking will be required, foods older than seven days old must be discarded, and fresh wild mushrooms must have documentation showing proof that they are one of eighteen acceptable P.O. Box 47825 species. Children will not be allowed to order raw foods under the blanket of a consumer advisory notice, and noncommercially produced caramel apples will no longer be considered exempt from permitting.

The proposed rule also is adding a new section for facilities responsible for providing meals for concerns and young children such as child care centers and early learning programs. These changes are intended to reduce

the current regulatory gaps and overlaps in food safety standards between agencies.

The Washington State Department of Health is holding informal public workshops to gather further comments on the draft rule during the month of January. Call (509) 962-7515 for the details.

KCPHD Considers Sanitary Survey Inspection Fee

In December, KCPHD held a public hearing during the Board of monitoring Health (BOH) meeting to consider up to date the adoption of sanitary survey inspection fees for group B public water systems (serving three to fourteen connections.) According to the draft policy, sanitary survey inspections would occur once every five years to identify minor and major deficiencies

and to ensure that proper maintenance and requirements are according to regulations.

Prior to adopting fees, KCPHD was given direction by the BOH to form a citizen's advisory committee to develop code to consider adoption of a group B sanitary survey program in Kittitas County.

Teens Against Tobacco Use (TATU) Trainings Held

During October, health educator Kasey Knutson organized two TATU trainings for local youth.

TATU trains middle school and high school students to be peer educators to prevent youth tobacco initiation. After the training, they work with their school advisors to set in classrooms

with younger peers.

Drinking Water

Eleven youth were trained from Cle Elum Roslyn High School and nine were trained from Ellensburg and Kittitas High Schools.

BOH Recommends Use of Reserves to Fill Budget Deficit

During the October Board of Health (BOH) meeting, public health administrator Maria D. Canfield presented KCPHD's 2012 budget proposal which included a deficit of \$182,566.

Projected revenues for 2012 are \$1,039,884 and projected expenses are \$1,222,449. The vast majority of expenses are related to payroll and indirect

BOH recommended that KCPHD plan to use its savings account to fill the budget deficit given that the county budget was not yet finalized.

Ms. Canfield also gave an overview of KCPHD staffing over the past few years which can be seen in the table below. In December, BOH approved a proposal by Ms. Canfield to create an ad hoc work group to conduct a study to research potential stable funding sources for public health. BOH member Rich Elliot will chair the work group.

In addition to reelecting members, Hartwig Vatheuer was re-elected as the BOHAC Chair, Carin Thomas was elected as Vice Chair, and Margaret Condit was reelected as Treasurer.

KCPHD Receives Quality Improvement Training Grant

In October, KCPHD was awarded about \$9,800 to provide quality improvement training for staff, with a special focus on Lean methodology. The grant is from Washington State Department of Health Public Health Performance Management Centers for Excellence.

All KCPHD staff will attend an all-day training customized especially for the department's needs. Following the all-staff training, a more in-depth training will be provided to the **Quality Improvement** Leadership Team (QILT.)

The goal of the trainings is to invest in skill-building for all

staff, familiarize everyone with the concepts of quality improvement, and introduce Lean concepts.

As a follow up, the QILT also hopes to learn more about Kittitas Valley Community Hospital's Lean and quality improvement efforts.

(Continued from page 1) Child Dentistry (ABCD) program, which links Medicaid eligible children to dentists. Funding cuts in 2011 include HIV, tobacco, and obesity prevention activities.

Because of a continuing downturn in the economy and the decrease in development,

there is an on-going decrease in on-site sewage system applications, food establishment renewals, well reviews, and water availabilities.

However, despite the declines in some areas, 2011 also saw increases in funding in ABCD, quality improvement, and

community health assessment and planning.

In 2012, we look forward to continuing to expand our existing partnerships and create new working relationships with our community members for the health of Kittitas County.
