All bid proposals shall be accompanied by a bid proposal deposit in cash, certified check, cashier's check or surety bond in an amount equal to five percent (5%) of the amount of such bid proposal. Should successful bidder fail to enter into the contract within the time stated, the bid proposal deposit shall be forfeited to Kittitas County.

Maps, plans and specifications may be obtained from this office upon payment of the amount of fifty and no/100 dollars (\$50.00) plus two dollars and 70/100 (\$.27) postage & handling. Informational copies of maps, plans and specifications are on file for inspection at the Kittitas County Department of Public Works in Ellensburg, Washington, and the offices of the McGraw-Hill, FW Dodge plan centers in Seattle and Tacoma, Inland Northwest Chapter of Associated General Contractors in Spokane, and Yakima Plan Center.

Before a contract will be awarded for the Work contemplated herein, the County will conduct such investigation as is necessary to determine the performance record and ability of the apparent low Bidder to perform the size and type of work specified under this contract. To demonstrate qualifications to perform the Work, each Bidder must be prepared to submit within 5 days after Bid opening and upon the County's written request evidence, such as financial data, previous experience, present commitments, and other such data as may be called for in the Contract Provisions.

This work shall include demolition and replacement of the existing bridge. All work shall meet all Federal, City and County Codes. Bid range is \$800,000 to \$900,000.
