A RESOLUTION AMENDING WEED SECTION BOUNDARIES

RESOLUTION NO. 2015 -____

- Whereas: The Kittitas County Noxious Weed Control Board was created in 1969 by RCW 17.10.020(1); and
- **Whereas:** The Kittitas County Noxious Weed Control Board, comprised of Sections One through Five, was activated in 1991 by the Board of County Commissioners, pursuant to Resolution 91-29; and
- Whereas:Resolution 91-29 contains numerous scrivener's errors in the legal descriptions
of the Weed Control Board Sections One through Five; and
- Whereas:The Cities of Ellensburg and Kittitas were not included in any Weed BoardSection created by Resolution 91-29; and
- Whereas: It is in Kittitas County's best interests to correct the numerous scrivener's errors contained in the Weed Board Section legal descriptions set forth Resolution 91-29, as well as to include the Cities of Ellensburg and Kittitas in a Weed Board Section; and
- Whereas: RCW 17.10.050(1) authorizes the Kittitas County Board of County Commissioners to set the boundaries of the Kittitas County Noxious Weed Control Board Sections One through Five, and to include the entire County in a Weed Board Section;

NOW, THEREFORE, BE IT RESOLVED, the Kittitas County Board of County Commissioners amends the legal descriptions of the Kittitas County Weed Board Sections One through Five, as set forth in Resolution 91-29, as follows (additions to this text are shown by <u>underline</u> and deletions by strikeout):

Section #1

Beginning at the 1/4 Section Corner between Section 32, and Section 33, Township 19N, Range 17E W.M; thence North on the East Section lines of Sections 29, 20, 17, and 8, to the 1/4 Section Corner between Section 8 and Section 9; thence East to the 1/4 Section Corner between Section 9, and Section 10; thence North to the 1/4 Section Corner for Section 3 and 4; thence East to the SE Corner, SW 1/4, of NW 1/4 of Section 3; thence North to the NE Corner, NW 1/4, NW 1/4, of Section 3, thence East to 1/4 Section Corner for Section 3, T 19E, R 17E, and Section 34, T 20N, R 17E, W.M; thence North on the Center Quarter Section Line through Sections 27, 22, and 15, to the Center 1/4 Section Corner of Section 15; thence West to the 1/4 Section Corner between Section 15 and Section 16; thence South to the SW Section Corner of Section 15; thence West to the SW Section Corner of Section 16; thence North to the 1/4 Corner between Section 16 and Section 17; thence West to NW Corner of NE 1/4 of SW 1/4, in Section 17, thence South to the NW Corner of SE 1/4, of SW 1/4 of Section 17, thence West to <u>SNW</u> Corner of SW 1/4 of SW 1/4 of Section 17; thence North to 1/4 Section Corner between Section 17 and Section 18; thence West to the Center Quarter Corner of Section 18; thence South to NE Corner of SE 1/4 of SW 1/4 of Section 18; thence West to NW Corner of SW 1/4 of SW 1/4 of Section 18; on the Range Line, between T 20N, R 16E, and T 20 N, R 17 E. W.M.; thence North to NW Corner to T 20N, R 17E, W.M.; thence East to SW Corner of T 21N, R 17E, W.M.; thence North to the NW Corner of T 21N, R 17E; thence North to Kittitas County Boundary Line, in Section 13, T22N, R 16E, W.M.; thence following the Boundary of Kittitas County, East and South to the Range Line between T 21N, R 18E; and T 21N, R 19E, W.M,; thence South to the SE Corner of T 21N, R 18E, W.M.; thence East to NWE Corner of T 20N, R 18E, W.M.; thence South to NWE Corner of T 19E, R18E, W.M.; thence South to NWE Corner of T 18 N, R 18E, W.M.; thence South to the NE Corner of SE 1/4 of NE 1/4 of Section 12; thence West to the NW Corner of SE 1/4 of SWNE 1/4 of Section 12; thence South to the NWE Corner of NW 1/4 of SE 1/4 of Section 12; thence West to the Center 1/4 Section Corner of Section 12; thence South to the 1/4 Section Corner between Sections 12 and 13; thence West to the NW Corner of Section 13; thence South to the NW Corner of Section 36, and the Ellensburg City Limits; thence West and South following Ellensburg City Limits to intersection with township line in Section 34, T 18N, R 18E, and T 17N, R 18E W.M.; thence West to its Intersection with Yakima River in Section 33 to the Ellensburg City Limits; thence East and South following the Ellensburg City Limits to the intersection with the township line between T 18N and T 17N, W.M.; thence continuing to follow the Ellensburg City Limits South and West to its intersection with the Yakima River Channel in Section 10, T 17N, R 18E, W.M.; thence North and West following the Yakima River Channel to Center 1/4 Corner between Section 33, T 19N, R 17E, W.M. thence West to 1/4 Section Corner between Section 33, and Section 32; and point of Beginning.

Section #2

Beginning at the 1/4 Section Corner between Section 32, and Section 33, T 19N R 17E, W.M.; thence South to the two mile later of the South Branch Canal; thence Westerly following the Lateral Canal, and including its Rights of Way, to the South Branch Canal; thence following the South Branch Canal, and including its Rights of Way to the Township line between T 18N, R 17E, and T19N, R 17E, W.M.; thence West to SW Corner of T 19N, R 17E; thence West to SW Corner of T 19N, R 16E; thence West to SW Corner of T 19N, R 15E; thence South to NE Corner of T 18N, R 14E, thence West to NE Corner of T 18N, R 13E; thence West to Kittitas County Boundary Line, Section 6, T 18N, R 13E, W.M.; thence Westerly following Kittitas County Boundary Line to Township Line, in Section 365, between T 18N, R 132E, and T 19N, R 132E, W.M.; thence West on Township line to Kittitas County Boundary Line in Section 52, T 18N, R 121E, W.M., thence Easterly following the Kittitas County Boundary Line to the Yakima River Channel in Section 33, T 15N, R 19E, W.M.; thence North and West following the Yakima River Channel to Intersection with Center 1/4 Section Corner of Section 33, T 19N, R 17E, W.M.; and Point of Beginning.

Section #3

Beginning at the Section Corner between Sections 25, 26, 34 and 35; in T 18N, R 18E, W.M.; thence North to the NW corner of Section 13NW Corner of Section 13, T 18N, R 18E, W.M.; thence East to 1/4 Section Corner for Section 12 and 13; thence North to the Center 1/4 Section Corner, Section 12; thence East to the NWE Corner of NW 1/4 of SE 1/4 of Section 12; thence North to the NW Corner of SE 1/4 of SWNE 1/4 of Section 12; thence East to the NE Corner of SE 1/4 of NE 1/4 of Section 12; thence North to the NWE Corner of T 18N, R 18E, W.M., thence North to the NWE Corner of T 19N, R 18E, thence East to the SW Corner of T 20N, R 19E; thence North to the NWE Corner of T 20N, R 18E; thence West to the SW Corner of T 21N, R 189E; thence North to the Boundary Line for Kittitas County, to the Columbia River Channel, in Section 5, T 20N, R 22E, W.M.; thence Southerly following the Columbia River to Township Line, between T 17N, R 23E, and T 18N, R 23E, W.M.; thence West to the SE Corner of T 18N, R 22E, W.M.; thence West to the SE Corner of T 18N, R 21E; thence West to the SE Corner of T 18N, R 20E, thence West to the SE Corner of T 18N, R 19E; thence to the SE Corner of T 18N, R 18E; thence West to the Ellensburg City Limits in Section 36; thence North and West following Ellensburg City Limits to NE Corner of Section 35, T 18N, R 18E, W.M.; thence Morth along this line and the West lines of Section 24 and Section 13, to the NW Corner of Section 13, T 18N, R 18E, W.M.; and Point of Beginning.

Beginning at the Intersection of Yakima River Channel and the Township Line Between T 17N, R 18E, and T 18N, R 18E, W.M.; thence East to 17N, R 18E, W.M.; thence South and East following the Ellensburg City Limits to the Township Line between T 17N, R 18E, and T 18N, R 18E, W.M.; thence East to the SW Corner of T 18N, R 19E, W.M.; thence East to the SW Corner of T 18N, R 20E, thence East to the SW Corner of T 18N, R 21E; thence East to the SW Corner of T 18N, R 22R; thence East to the SW Corner of T 18N, R 23E; thence East to the Columbia River Channel in Section 31, T 18N, R 22E, W.M.; thence Southerly following the Columbia River Channel to Township Line between T 14N, R 23E, and T 15N, R 23E, W.M., which is Kittitas County Boundary Line. Thence West to SE Corner of T 15N, R 20E; thence West to the SE Corner of T 15N, R 19E; thence West to SE Corner of T 15N, R 20E; thence West to the SE Corner of T 15N, R 19E; thence West to the Yakima River Channel in Section 33, T 15N, R 19E, W.M.; thence Northerly following the Yakima River Channel to Township Line, between T 17N, R18E, and T 18N, R 18E, W.M.; thence Northerly following the Yakima River

ALL LANDS WITHIN THE CITY OF KITTITAS TO BE EXCLUDED

Beginning at the SW Corner of T 19N, R 17E, W.M.; thence East between T 18N, R 17E and T 19N, R 17E; to South Branch Canal. Thence Northerly following the South Branch Canal and including its rights of way to Two Mile Lateral in Section 31, T 19N, R 17E; thence Easterly following the Two Mile Lateral and including its rights of way to Intersection of the Section Line for Section 32 and 33; thence North on the East Section Lines of Section 29, 20, 17, and 8, to the 1/4 Section Corner for Section 8 and 9; thence East to the 1/4 Section Corner for Section 9 and 10; thence North to the 1/4 Section Corner for Section 3 and 4; thence East to the SE Corner, SW 1/4, NW 1/4, of Section 3; thence North to the NE Corner, NW 1/4, NW 1/4, of Section 3; thence East to the 1/4 Section Corner for Section 3, T 19<mark>EN</mark>, R 17E, and Section 34, T 20N, R 17E; W.M.; <u>Ft</u>hence North on the Quarter Section Line through Sections 27, 22, and 15; to the Center 1/4 Section Corner of Section 15; thence West to the 1/4 Section Corner Between Section 15 and 16; thence South to the SW Section Corner of Section 15; thence West to the SW Section Corner of Section 16; thence North to 1/4 Corner for Section 16 and 17; thence West to NW Corner of NE 1/4 of SW 1/4 in Section 17; thence South to NW Corner of SE 1/4 of SW 1/4 of Section 17; thence West to SNW Corner of SW 1/4 of SW 1/4 of Section 17; thence North to 1/4 Section Corner for Section 17 and 18; thence West to the Center Quarter Corner of Section 18; thence South to NE Corner of SE 1/4 of SW 1/4 of Section 18; thence West to NW Corner of SW 1/4 of SW 1/4 of Section 18; on the Range Line, between T 20N, R 16E, and T 20N, R 17E, W.M.; thence North to NW Corner of T 20N, R 17E, W.M.; thence East to SW Corner of T 21N, R 17E, W.M.; thence North to NW Corner of T 21N, R 17E; thence North to Kittitas County Boundary Line in Section 13, T 22N, R 16E, W.M. Thence following the Boundary Line of Kittitas County, Westerly and Northerly; thence Southerly and Easterly to the Township line between T 18N, R 11E, and T 19N, R 11E, W.M. Thence East to SE Corner of T 19N, R 11E, W.M.; thence East to SE Corner of T 19N, R 12E; thence East to SE Corner of T 19N, R 13E; thence East to SE Corner of T 19N, R 14E; thence East to SE Corner of T 19N, R 15E; thence East to SW Corner of T 19N, R 17E, and Point of Beginning.
