

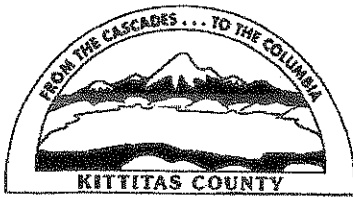

**A RESOLUTION ANNEXING CERTAIN REAL PROPERTY INTO FIRE PROTECTION DISTRICT NO. 6
AMENDED
(Elimination of Reference of Registered Electors, corrected to Property Owners)**

A resolution by the Board of Fire Commissioners of Kittitas County Fire Protection District No. 6, to accept the Petitions for Annexation of certain real property situated in Kittitas County, State of Washington to be annexed into and become part of the Kittitas County Fire Protection No. 6 and to file the Petitions for Annexation with the County Auditor.

WHEREAS, the Board desires to annex certain real property into the Kittitas County Fire Protection District No. 6 service area; and

WHEREAS, on or about February 3, 2010 the Board received petitions, signed by certain qualified Property Owners of the real property proposed to be annexed; and

WHEREAS, the legal description of the area petitioned for annexation includes Tax parcel 516935 located in the East half of Section 9, Tax parcel 15038 located in the East half of Section 16, Tax parcel 696935 located in the East half of Section 21, Tax parcel 706935 consisting of the Entire Section 22, Tax parcel 756935 located in the North half and Southeast Quarter of Section 27, Tax parcel 746935 consisting of the Entire Section 26, Tax parcels 19443, 17950, 247235, 13512, 20611, and 20612 located in the North half and Southeast one third of Section 35, Tax parcel 257235 consisting of the Entire Section 36 all in Township 21 North, Range 14 East. Tax parcels 12064, 950570, 950761, 12063, 950762, 950581, 950582, 950583, 950584, 950585, 950586, 950587, 950588, 950589, 950590, 950591, 950592, 950593, 950594, 950595, 950596, 950597, 950598, 171934, and 12065 all located in the North three quarters and the East three quarters of the South quarter of Section 1 in Township 20 North, Range 14 East. Tax parcels 20435, 366034, 20433, and 20434 all consisting of the Entire Section 6, Tax parcels 376034, 13511, and 13510 all located in the North half of Section 7, Tax parcel 356034 located in the South half of Section 5, Tax parcels 599434, 13504, 13505, 952045, 950733, 950734, 950735, 950736, and 950737 all consisting of the Entire Section 8, Tax parcels 329434, 13519, 13520, and 13521 consisting of the Entire Section 9 all in Township 20 North, Range 15 East.; and

WHEREAS, in the absence of a Boundary Review Board, Chapter 52.04 RCW governs annexations for fire protection districts; and

WHEREAS, the petition method of annexation is an alternative method to the election method, and is governed by RCW 52.04.031, 041, and .051, as well as by other statutes to which reference is made within those statutes; and

WHEREAS, in accordance with RCW 52.04.031, the annexation petition was filed with the board of fire commissioners of Fire Protection District No. 6, signed by the owners of at least 60% of the area of land to be annexed, and included a legal description and a plat outlining the boundaries of the proposed annexation; and

WHEREAS, upon verification of sufficiency of qualified property owners presiding within the petitioned territory the Board of Fire Commissioners of Kittitas County Fire Protection District No. 6 ordered a public hearing be held authorizing annexation of the above territory; and

NOW THEREFORE; be it resolved by the Board of Fire Commissioners of Kittitas County Fire Protection District No. 6 that the Board accepts the Petitions and shall forward the Petitions to the Kittitas County Assessor's Office to certify the sufficiency of the signatures.
